## **13. MOTIONS ON NOTICE (REPRESENTATION)**

### **13.1 The 112th Guild Council:**

- 13.1.1 Recognises that Western Australia will have both a State and Federal election before the end of May this year.
- 13.1.2 Encourages all students to make their voices heard and update, check or enrol to vote, with the deadline for enrolling to vote in the State election being the 13th of February at 6pm.

- 13.2.2 Recognises that these attacks are part of the concerning pattern of growing Islamophobia, anti-Palestinian racism and suppression of free-speech in Australia.

**14. MOTION WITHOUT NOTICE (REPRESENTATION)**

**14.1 The 112<sup>th</sup> Guild Council:**

14.1.1 Notes that Israel has proceeded to shut down the UNWRA office in Occupied East Jerusalem and has carried out military campaigns including the so-called "Operation Iron Wall" in the Occupied West Bank, concurrently with the first phase of the Israel-Hamas ceasefire.

14.1.2 Condemns remarks from U.S. President Donald Trump that he would like to 'just clean out' Gaza and transfer more Palestinians to Egypt and Jordan.

14.1.3 Endorses the demands of the February 27 Student Strike are for the ceasefire to hold, for no further bombing, for a full withdrawal of Israeli troops out of Gaza and for full Palestinian control over the rebuilding of the Gaza Strip.

**14.2 The 112<sup>th</sup> Guild Council:**

14.2.1 Stands against incoming U.S. President Donald Trump and his administration's far-right, anti-worker agenda for the U.S.

14.2.2 Condemns Trump for being a far-right, billionaire bigot.

14.2.3 Condemns what the Chief Executive of the Jewish Council for Public Affairs and a number of historians have identified as an unambiguous fascist salute by Elon Musk after Trump's inauguration.

14.2.4 Notes that all of the U.S's most powerful billionaires attended Trump's inauguration rally and that many have embraced his administration's reactionary agenda.



14.2.5 Directs the UWA Guild Marketing team to make a post on all Guild social media channels to publicise the content of this resolution to the student body.

### **14.3 The 112<sup>th</sup> Guild Council:**

14.3.1 Condemns the divisive and harmful rhetoric perpetuated by Peter Dutton, leader of the Liberal Party, including:

- a) Racism toward Indigenous Australians, seen in his opposition to flying the Aboriginal and Torres Strait Islander flags alongside the Australian flag and his dismissal of concerns about “Australia Day.” (26/01/2025)
- b) Homophobia, evident in his opposition to Australian Defence Force events that acknowledge and show solidarity with individuals who have experienced homophobia, biphobia, interphobia, and transphobia, as part of the International Day Against Homophobia, Biphobia, Interphobia, and Transphobia. (21/05/2021)
- c) Racism toward minority groups in the Australian community, including:
  - Generalizing that most terrorist-related offences are committed by individuals of “second and third generation Lebanese-Muslim background.” (23/11/2016)
  - Suggesting that people in Melbourne ‘fear’ leaving their homes due to “gang violence” involving African Australians. (3/01/2018)
  - Claiming that Muslim candidates gaining parliamentary seats would be a “disaster.” (4/07/2024)
  - Labelling refugees from Gaza as a “national security risk.” (14/09/2024)

14.3.2 The Guild Council recognizes that this rhetoric causes division within Australia’s multicultural society, undermining values of respect, inclusion, and harmony.

14.3.3 The Guild Council encourages solidarity with groups targeted by Dutton’s comments and resolves to stand with affected communities.

14.3.4 The Guild Council directs the Guild to:

- Promote and support services for students belonging to communities affected by these comments.

14.4.4 Encourages University Hall to halt encumbrances to allow students to get their completion letters as it will affect their ability to get a visa in Australia while the dispute is ongoing

14.4.5 Encourages RSD President to investigate the issue further

14.4.6 Encourages RSD to collaborate with relevant stakeholders to create online resources that explains to students the importance of their property condition report and informs new residents how to complete it during O week
